Sunday offerings were about \$240,000 below budget.

School subsidy was about \$55,000 more than budgeted.

Capital campaign statements have not been sent out during pandemic, but pledged money has continued to come in.

Semi-Annual School Commission Report - Kevin McCusker See Attached

School enrollment is below budgeted and there are more multi-child discounts than anticipated so we should expect a greater than budgeted subsidy, before considering the PPP Loan proceeds received.

Kevin explained the quarantine plan in the case of any Covid cases among students.

Commission Updates

Faith Formation and Catechesis Commission – Pat Wachtel

The commission and most of the groups it oversees have not been able to meet during the pandemic. RCIA, adult faith formation and Sunday morning religious education (currently around 50 enrollees) is happening.

IT/Communications Update & Discussion - Patrick Jendraszak and Mark Garza

Patrick discussed an add-on that allows easier online and mobile payments.

The committee will continue to research apps to improve parish communications.

We received the grant applied for from the Center of Congregations in the amount of \$5,000. It was used for equipment and an institutional Zoom account.

Patrick provided plan to begin opening the facility to meetings.

There was discussion about how to support the Thanksgiving Sharing program, given challenges, especially with packing the boxes, in the current environment.

From Your Finance Council: Covid-19 Affects Parish Finances

Our fiscal year closed June 30, 2020 with a loss of \$256,034, primarily due to the economic effect of the COVID-19 pandemic.

Without weekend Masses from March through May, Sunday offerings had a loss of \$240K to budget.

Other ministries feeling the burden of the pandemic included: Athletics, with a loss of nearly \$10K; St. Luke Childcare and Preschool, which operated at a loss of \$43K; and our School Ministry, whose loss/subsidy was \$55K greater than budgeted. These losses would have been worse, if not for incorporating various operational savings strategies, such as lowered heating and cooling.

All employees were kept on payroll throughout the academic year. Our parish and school staff transitioned to working at home and continued to provide necessary services to the community.

We applied for and received a Payroll Protection Plan (PPP) loan in the amount of \$729K. Since loan forgiveness has not been determined, it is also considered a liability on our balance sheet.

However, we expect this PPP loan will be forgiven in the coming year, which will more than offset the deficit noted above and provide us with a contingency for the new fiscal year, which began on July 1.

Rest assured of our gratitude for your support. May our God, from whom all good gifts come, bless you and your families in abundance. May you enjoy health in mind and body during this difficult time.



Providence 2021

Thanks to your generosity, we have been able to begin our Capital Building project. We currently have nearly \$2 million on hand, after paying back the Parish Rainy Day Fund for an advance of \$169 thousand for this project and paying for a substantial amount of our architectural fees for the entire project.

PARISH FINANCES

Parish Assets Our Accounts

At right is our starting and ending balances for each of our asset accounts.

Operating Cash, exclusive of the PPP loan proceeds, is \$756,716, a drop of \$100K.

The Rainy Day Fund increased due to the repayment of \$169K from the Providence 2021 Capital Campaign and interest.

Our Maintenance Fund's modest increase was due to interest and it will finance our roof replacement by the school and parish warming kitchen in FY 2020-2021.

September 15, 2020

We had our first School Commission meeting of the 2020-21 school year on August 11, 2020. We welcomed our new principal and reviewed the school reopening plan. The school reopened on August 19, 2020, with the students, faculty and staff, and school families happy to return after a five month break from in-person classes.

Enrollment

Enrollment this year is 532, compared to a budgeted number of 542. A handful of students left St. Luke for online learning at a public school, and a slightly smaller number of students came from area public schools for in-person learning at St. Luke. Enrollment last year was 562 and enrollment the year before was 572. Most of the projected decrease is due to a larger-than-average graduating class.

Re-Entry Plan

The faculty and staff have done an outstanding job in preparing the school. We have been hearing strong positive feedback on how the school has handled reopening. The students are happy to be back in class and are wearing facemasks consistently.

Finance

In addition to a smaller enrollment compared to the budget, the family makeup has led to a larger gap in the budget. The budget was based on 542 students coming from 359 families, and actual enrollment is at 532 students coming from 323 families. As a result, we have a higher number of multi-child families that pay a discounted tuition rate. We are reviewing the basis of our projections to determine where the difference is from. As a result of lower tuition payments, the current projected difference in revenue from the budget for the school is \$130,000. The expenses have not yet been updated, so the overall loss may be different.

Strategic Plan

We are in the final year of the current Strategic Plan. A sub-committee of the School Commission will work with the administration this year to develop the Strategic Plan for 2021-2024.
